Eligibility Requirements

- Nonprofit status or:
 - Government Agency, or
 - Community Group w/ fiscal agent, or
 - Public Agency, or
 - Educational Institution
- Services/programs provided in one or more of the geographic areas of Fresno, Madera, Tulare, Merced, Mariposa and Kings Counties.
- Financial Health measured by:
 - IRS 990, and
 - Internal audits for budgets less than 300K, and
 - External audits for budgets more than \$300K, and
 - Operational budget for organization
 - Minimum of five board members. Board members should be volunteers who reflect cultural, gender or age diversity with various experiences and backgrounds.

Fresno Regional Foundation will **NOT** consider grant requests for the following:

- Previously incurred expenses
- Fundraising by one agency on behalf of another
- Endowments
- To institutions limiting their services to persons of a single religious sect or denomination
- To Individuals

Arts and Culture

Goals to Fund

To fund existing organizations with new or ongoing programs that:

- Integrate arts and cultural activities in order to benefit the economic and educational needs of our community
- Invest in and support the rich, diverse changing culture in the Central San Joaquin Valley
- Increase awareness, participation and understanding in all arts and culture activities
- Invest in programming strategies that help the organization remain vital and relevant in their communities

Grant Amounts and Duration

The Fresno Regional Foundation will be granting approximately \$100,000 in the Arts and Culture grant cycle. A grant of \$35,000 will be awarded to one organization. Remaining grant amounts will range from \$1,000 to \$15,000.

Generally, funding will be awarded for a one-year period but may vary depending on the amount of time necessary for grantees to meet the objectives described in their funding request.

Special Considerations

Due to donor-imposed restrictions, \$50,000 is earmarked for those organizations whose offices are located within the City of Fresno. Programs and projects that are outside the City of Fresno will be considered as long as the main office is located within the City of Fresno.

Partnership with the California Cultural Data Project (California CDP)

This year marks the second year that the Fresno Regional Foundation is engaging in a partnership with the California Cultural Data Project (California CDP). The California CDP is a statewide, collaborative effort of public and private funders throughout California and consists of an online system for collecting and standardizing historical financial and organizational data. The Fresno Regional Foundation, along with other funders in California, now requires Arts & Culture applicants to complete a Cultural Data Profile through the California CDP Website at www.caculturaldata.org. Applicants must fill out the Cultural Data Profile once each year and use that data as part of their application to California participating funders.

The California CDP will provide the cultural community with consistent, reliable, comprehensive data on arts and culture in California, enabling organizations to view trends in their data, benchmark themselves against peer organizations, and enhance their organizational capacity.

Youth

Goals to Fund

- Address the social, education, and health challenges in the community.
- Empower Youth
- Promote youth civic engagement and service-learning in the community
- Invest in programming strategies that help the organization remain vital and relevant in the applicant organization's community.

Grant Amounts and Duration

The Fresno Regional Foundation will be granting approximately \$100,000 in the Youth Grant Cycle. Grant amounts range is \$1,000 to \$25,000. Of this amount, \$10,000 will be earmarked specifically for charter school petition development. For additional information, please see the Youth Addendum on page 14.

Special Considerations

Due to donor-imposed restrictions, \$20,000 is earmarked for those organizations whose offices are located within the City of Fresno. Programs and projects that are outside the City of Fresno will be considered as long as the main office is located within the City of Fresno.

The Foundation will be granting \$10,000 for grant applications that demonstrate greatest capacity in the areas of charter school programmatic innovation directed at low income communities and communities of color. Grant funding for charter school innovation will be awarded in two phases, in the amount of \$5,000.

Human Services

Goal to Fund

- To fund capacity-building strategies that focus on board governance, leadership development, or fiscal management.

Grant Amounts and Duration

The Fresno Regional Foundation will be granting approximately \$410,000 in the Human Services Grant Cycle. Of this amount **\$300,000 has been earmarked specifically for Teen Pregnancy Prevention**. For additional information, please see the TPP Addendum on page 15.

In this Human Services Grant Cycle, FRF will invest in strengthening the organizations serving the Central Valley. Therefore, FRF will fund programs that focus on **capacity-building strategies** for Community Benefit Organizations (CBOs) in Fresno, Tulare, Madera, Merced, Kings and Mariposa counties. Fresno Regional Foundation will be granting approximately **\$110,000 specifically for Human Services**.

Special Considerations

The Foundation will be granting approximately \$300,000 in the area of Teen Pregnancy Prevention (TPP). (See *TPP Addendum for details on page 15*).

Due to donor-imposed restrictions, \$30,000 of the \$110,000 is earmarked for those organizations whose offices are located within the City of Fresno. The remaining \$80,000 will fund organizations in all 6 counties.

APPLICATION PROCEDURES

The Fresno Regional Foundation is improving the online website submission process. Please pay close attention to the details of our requirements and contact us with any questions.

Create an Account with Fresno Regional Foundation

The Fresno Regional Foundation is proud to introduce our improved Online Grant Application (OLGA) System for the 2010 Grantmaking year.

To get started go to www.fresnorefoundation.org and select the Grantmaking Tab, then select **Apply for a Grant** where it will lead you to the page entitled **Application Procedures**.

1. Select #3 "First Time user. Create an account" and complete the online form.
2. Once completed hit "Submit" at the bottom of the page
3. If submission is successful the landing page will be "Submission Confirmed". Then select link highlighted "please proceed to login".

NOTE –

If you leave the site and return to www.fresnorefoundation.org select the Grantmaking Tab and select **Apply for a Grant**. Simply select #4 Returning Users: Log in and Start an application and login. If you forgot username or password information you must have the email address of the person who created the account to retrieve both username and password. They will be sent to the email address of the person who created the account.

Organization Profile Form (OPF)

This form allows the Foundation to collect important information about your organization and prepares us to receive your grant application by providing an organization profile number. We encourage all organizations to submit an OPF as soon as possible each calendar year. Once completed your organization may apply to one or all of our annual grant cycles.

- * **An organization profile number is required in order to complete an application.**
- * **Your OPF must be updated each year in order to apply.**

One week prior to the application deadline date, we require a complete **OPF** with the appropriate attachments. Simply Login with your organization account at www.fresnorefoundation.org/login and click on **Start Here** on the left hand side.

1. Select #3 Complete Organization Profile Form and complete online form.
2. If you want to save and return to the document later, simply scroll down the page to "Submission Status" drop-down button and select **Save and Return for Editing** and hit "Save / Submit" button.
3. Once the form is completed to satisfaction, scroll down to "Submission Status" drop-down button and select **Submit to FRF** and hit "Save / Submit" button.
4. If your OPF is saved or submitted successfully, you will receive a confirmation message immediately following your submission on the website.

NOTE –

- 1) If you have already completed an Organizational Profile Form and have a profile number, you are still required to submit updated information each year before applying. Fill in your profile number in the appropriate field, complete the form, and submit with updated attachments.
- 2) One week prior to a grant deadline, you will not be able to make changes to the OPF until a Program Officer has verified your OPF.

- 3) When a program officer has verified your OPF, you will receive an email confirmation indicating you may review your document on the webpage **Saved and Submitted Docs**. The status of the OPF will be available for you to view including details from the Program Officers, if any additional items are needed. You will be able to once again view and edit your OPF online.

Please make certain all attachments are named appropriately, identifying 1) your organization and 2) the type of document being sent as an attachment. For example, Fresno Regional Foundation documents would be labeled as an EXAMPLE: **FRF 990 2010, FRF Audit 2009, FRF Board 2010, and so on.** **All documents must be labeled appropriately.**

Application

Once your organization has created an account then completed and submitted an Organization Profile Form (OPF) go to www.fresnoregfoundation.org/login. Simply login with your organization account and click on **Start Here** on the left hand side.

1. Select #4 Submit Grant Application and complete online form.
2. If you want to save and return to the document later, simply scroll down the page to “Submission Status” drop-down button and select **Save and Return for Editing** and hit “Save / Submit” button.
3. Once the form is completed to satisfaction, scroll down to “Submission Status” drop-down button and select **Submit to FRF** and hit “Save / Submit” button
4. Please don't forget to attach your Budget at the bottom of the page.
5. If your Grant Application is saved or submitted successfully, you will receive a confirmation message immediately following your submission on the website.

NOTE –

- 1) Prior to the Grant Deadline, any changes to SUBMITTED Grant Application, you must contact the Program Staff via email, Sandra@fresnoregfoundation.org and Carla@fresnoregfoundation.org. They will be able to make your application available to you so you can make the necessary changes.
- 2) When a program officer has verified your SUBMITTED Grant Application, you will receive an email confirmation indicating you may review your document on the webpage **Saved and Submitted Docs**. The status of the Grant Application will be available for you to view including details from the Program Officers if any additional items needed.

Grant Reporting Requirements

The Final Report must be submitted online from our OLGA System. **Please review the Final Report requirements carefully when applying. Organizations must be prepared to comply with all reporting requirements at the end of the grant period.** Additionally, copies of press releases and/or media contacts resulting from the grant award can be uploaded and submitted with the Final Report. Failure to submit the Final Report may disqualify the grantee from future funding requests.

To get started go to www.fresnoregfoundation.org/login. Simply login with your organization account and click on **Start Here** on the left hand side.

1. Select #5 Submit Grant Final Report and complete online form.
2. If you want to save and return to the document later, simply scroll down the page to “Submission Status” drop-down button and select **Save and Return for Editing** and hit “Save / Submit” button.
3. Once the form is completed to satisfaction, scroll down to “Submission Status” drop-down button and select **Submit to FRF** and hit “Save / Submit” button
4. Please don't forget to attach your Budget at the bottom of the page.
5. If your Grant Final Report is saved or submitted successfully, you will receive a confirmation message immediately following your submission on the website.

APPENDIX – FOR ARTS AND CULTURE APPLICANTS ONLY

New partnership with the California Cultural Data Project (California CDP)

The Fresno Regional Foundation, along with other public and private funders in California, is partnering with the Cultural Data Project for the second year. Applicants are required to complete a Cultural Data Profile through the California CDP Website (<http://www.caculturaldata.org>).

The California CDP is an online system for collecting and standardizing historical financial and organizational data and will provide the cultural community with consistent, reliable, comprehensive data on arts and culture in California. It is hoped that access to this data will enhance both individual organizational capacity as well as the overall effectiveness of the nonprofit cultural community in our state. Applicants applying to more than one of the participating Grantmakers will only need to complete this form once each year.

Participation in the California Cultural Data Project (California CDP) is required for all Fresno Regional Foundation Arts and Culture applications. As part of the application process, it is also due to the Fresno Regional Foundation by **January 22, 2010**.

Instructions for the Use of the California CDP:

1. Your organization must be registered with the California CDP website by creating an organizational login ID and password.
2. Your organization, or arts program/department within a larger organization, will enter historic financial and programmatic information for completed fiscal years using board-approved audits or reviews. If your organization is not audited, you will enter information from your board-approved year-end financial statements. **Please note, your grant application budgets and narratives are NOT collected by the California Cultural Data Project and will remain part of the Fresno Regional Foundation application.**
3. If this is your first year of use, you are asked to **complete a Cultural Data Profile for each of the two most recently completed fiscal years.** (Going forward, you will only need to provide one year of data.)
4. Once you have completed and submitted your Cultural Data Profile, go to the “Funder Reports” section of the California CDP website and generate the Funder Report for Fresno Regional Foundation, and attach it with your Organization Profile materials. To view any of the reports, you must have Adobe Acrobat Reader installed on your computer. Relevant information from the applicant’s Cultural Data Profile will automatically be included in the Fresno Regional Foundation Funder Report. **Please be sure to review your Funder Report.**
5. The California CDP Help Desk will review each of your submitted profile(s) and contact you with suggested revisions. It is your responsibility to respond and to make all necessary changes to the submitted Data Profile(s). Making these suggested revisions may help you represent your organization more accurately in the Funder Reports you use as part of your application to participating grants programs and in the powerful User Reports.

Youth Addendum

Special Considerations

The Fresno Regional Foundation (FRF) will award \$10,000 in two phases, each phase for \$5,000. This grant award is intended to be used for expenses incurred in the planning and development of a charter school petition prospectus and submission-ready petition.

Focus of Grant:

This grant is for the development of public charter schools in low achieving districts, low-income communities and communities of color. Toward that end, the funding will support the development of teams for the purpose of planning, researching, and the drafting of petitions for high-quality and high-capacity charter school.

Funding Phases:

1. Planning
 - a. Prior to the development of the charter petition, applicants will submit a proposal to FRF that outlines the proposed school's founding team, mission and vision, target population, academic programs, objective, and theory of change.
2. *Petition Development*
 - a. In order to receive full funding, the school development team must submit a completed public charter school petition that that is considered, by the development team, ready for submission to the intended authorizer, i.e., a school district or county office of education. The second phase is contingent upon successful execution of the *Planning* phase.

Allowable Expenses:

The grant award is intended to be used for expenses incurred in the planning and development of a charter petition, including:

- Training programs
- Professional Consultants
- Printing
- Research and data collection
- Professional conferences

Eligibility Criteria:

1. Meet all assurances and affirmation as required by the State of California
2. Meet all petition elements
3. Meet State Board of Education requirements and standards
4. Serve low-income communities and communities of color
5. Target population qualify for free or reduced lunch
6. Evidence-based models
7. High school charter petitions should include A-G course approved curriculum

Selection Criteria: *These factors will be considered:*

1. Programmatic innovation
2. Academic performance
3. Fiscal management
4. Accessibility and equity
5. Operation competency
6. Simultaneous preparation of Central Valley students for both higher education and career/workforce awareness and success.

TPP Addendum

Special Considerations

The Fresno Regional Foundation (FRF) will be awarding three \$100,000 two-year grants (50,000 per year).

Focus of Grants:

To fund programs that reduce teen pregnancy either by providing reproductive health services, or through advocacy, sexuality education or other youth development initiatives aimed at reducing teen pregnancy. Youth development initiatives should demonstrate working with young people in such a way that allows them to lead and/or develop initiative.

To fund programs in Fresno, Tulare, Madera, Merced and Kings counties that help organizations implement Teen Pregnancy Prevention programs.

Eligibility Criteria: *These factors will be considered:*

1. The program is medically accurate, comprehensive and free from bias.
2. The program is gender inclusive and appropriate.
3. The program is culturally and linguistically competent for its target population.
4. The program provides referrals to a family planning service provider (a letter of cooperation with a service provider can document this). NOTE: If the program is not providing reproductive health services we want to be certain young people can access services with the partner service provider. See list of Family Pact Clinics on FRF website.
5. The program is evidence-based (if you are using a curriculum that is new, please submit copy in a .pdf or Word document).
6. The organization has long-standing and deep knowledge of a community.
7. The organization has impact on long-term community change as is pertains to youth.
8. The organization is financially healthy.
9. The organization has a successful track record which demonstrates it has systems in place to manage programs and grants.

Selection Criteria: *These are items that will cause the applicant's proposal to receive a higher ranking:*

Programs that have high impact and focus on outcome,
Programs that have a service provider referral system developed.

Geographic Area:

Serving teen pregnancy Hot Spot Zip Codes based on census,

Programs that have a youth development focus,

Programs that involve parents or significant adult.

Programs that define outcomes well.

Sustainability of programs.

Knowledge of other organizations doing related work.

Grant specific budget.

Additional:

The Fresno Regional Foundation TPP Advisory Committee may conduct brief site visits for some of the top applicants for the larger awards.

The Letter of Cooperation is required if your program is not providing reproductive health services. The letter should identify partner service providers such as clinics. If the program is not providing reproductive health services we want to be certain young people can access services that meet Eligibility Criteria #1. Grantees will be asked to submit a written report at the end of the first year of the two-year grants. Site visits will be conducted at six months and eighteen months.
